### WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT

In consideration for receiving permission to participate in the Lively Technical College Show and Shine Car Show on March 7, 2026, I, \_\_\_\_\_, for my heirs, executors and administrators, hereby release, waive, discharge and covenant not to sue The School Board of Leon County, Florida (LCSB), its officers, employees, agents, contractors or volunteers, from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me, whether caused by my negligence, the negligence of others, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted.

I am fully aware of the risks involved and hazards connected with the Lively Technical College Show and Shine Car Show and I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property, and I acknowledge that my participation is at my own risk. I voluntarily accept responsibility for my personal safety and welfare, and I assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me or any loss or damage to property owned by me, as a result of being engaged in such activity, whether caused by my negligence, the negligence of others, or otherwise.

I further hereby agree to indemnify and hold harmless LCSB, its officers, employees, agents, or volunteers from any loss, liability, damage or costs, including court costs and attorneys' fees, that may incur due to my participation in said activity, whether caused by my negligence, the negligence of others, or otherwise.

I understand that LCSB does not provide any insurance coverage for participants for any circumstances arising from their participation in this event or any activity associated with or facilitating that participation. As such, I warrant that I will make sure my vehicle is properly and sufficiently insured. I warrant that I will obey all traffic laws to, from, and when on the show grounds, that I will drive slow and safely when entering, parking, and exiting the event area, and that I will be respectful of others attending the event, park patrons, event staff and the surrounding neighbors.

By participating in the event I agree to allow LCSB to take photos at the event and to use those photos as LCSB sees fit, i.e. for possible promotion for future shows, website postings, etc.

I further understand that LCSB reserves the right to refuse admittance to or remove from participation any persons or vehicles which, in the sole opinion of Car Show coordinators, is not in keeping with the quality or safety of the show.
